We have a number of PRoW issues which require attention,

1) The bridge at the South East end of the KZ13 (see jpg 002 & 004). Are the rails to assist walkers or prevent walkers from using the bridge also a number of horizontal rails are rotten and require replacing. The whole bridge requires an inspection as you may be able to see from the attached appears to be sagging in the middle. Can you arrange for a safety inspection and if considered safe for our Lengthsman to repair are you able to provide relevant specifications for the materials. 2) At the north end of the KZ13 there is a kissing gate which can probably be repaired (see jpg 007) however the wooden finger post has rotted off (see 007 & 005) can you please advise specification for replacement of post and finger.

3) Can you advise the process of obtaining grant funding for this work to be carried out? Our Footpaths Officer has asked if there is a possibility of you meeting her so she can discuss and view other PRoW issues with her. Malcolm Walker Clerk to Kentchurch Parish Council

"Planning No 251052 Castle Farm Barns Kentchurch HR2 0BN The Parish Council considered this application at their May Annual Meeting

A number of issues were raised as follows:-

While the original Q Class Application was to re-purpose a disused farm building the new application will now disregard that application and create four new dwellings.

The proposal being in open countryside and outside the curtilage of either Pontrilas or Kentchurch, not in character to the locality and will not address the identified need for properties to support the local workforce.

It would appear that the Q Class Approval has been used as a stepping stone to allow a development which otherwise would have been unlikely to have received approval.

The Parish Council request that the proposed development should only receive approval if it would satisfy the needs of the locality.
